

GENERAL

EPORITE EHM-FR006 is a one-component epoxy hot melt system recommended especially for fiber-reinforced prepreg.

EPORITE EHM-FR006 can be laminated with appropriate carbon fiber to achieve UL94 V-0.

The cured EPORITE EHM-FR006 exhibits excellent physical properties such as mechanical strength, and heat stability.

STORAGE

Store EPORITE EHM-FR006 at temperature lower than 5° C.

<u>HANDLING AND</u> <u>SAFETY</u>

Gloves and glasses are suggested for user's personal protection. Clean with soap and water when skin contact.

PROCESSING

- 1. Coating process:70 ~75°C
- 2. Propreg storage: lower than 5° C
- 3. Molding process: 150°C/0.5~1 hr + 150 °C/2~2.5 hr.

NOTE: The process can be adjusted according to the specific manufacturing process or performance requirement.
